RPEN's efforts have contributed to constitutional protections of our PERS system; post-retirement increases of retiree pension benefits; and an awareness of the importance of a solvent, sound retirement system. We are also working with the Social Security Fairness Coalition to repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) so those with Social Security credits can collect more upon retirement.
